## **Cybersecurity and International Law**

(ESDC activity number 25-26/216/1)

**16 - 18 February 2025 – residential format, Brussels**

**Lodz Cyber Hub**, a research centre representing the University of Lodz, Poland, under the auspices of the **European Security and Defence College (ESDC)** is organising a full residential course on cybersecurity and international law from 16 to 18 February 2025 in Brussels. This course is a non-specialised cyber course at awareness level. It is linked to the strategic objectives of Pillar 3 of **the EU's Cybersecurity Strategy for the Digital Decade**<sup>1</sup>, reflects the priority on cyber within the **EU's Strategic Compass**<sup>2</sup> and supports the **European Cybersecurity Skills Framework (ECSF)** of ENISA<sup>3</sup> 'Cyber Legal, Policy and Compliance Officer' profile.

This course provides a practical approach to the application of international law in cyberspace, addressing current geopolitical challenges. Topics include state responsibility for cyber operations, cybersecurity due diligence, peaceful dispute resolution, transboundary data flows (GDPR, Big Data), artificial intelligence (AI) and algorithmic accountability, as well as intermediary liability. It also covers ongoing United Nations cyber processes, such as the recent Hanoi Convention, WSIS+20 process, the Second Additional Protocol to the Budapest Convention on **transnational data access**, as well as current dialogues on autonomous weapons systems, and AI liability.

It provides a platform to exchange views and share best practices on critical cyber-related issues. Through expert-led presentations, practical exercises, and interactive discussions, participants enhance their knowledge, skills, and strategic competencies in addressing cyber challenges. By the end of the course, they have practical understanding and tools required to apply international law effectively in cyberspace and strengthen their work in diplomatic, law enforcement, and military settings.

Part of the ESDC's EAB.Cyber/Cyber Education Training Exercise and Evaluation (ETEE) platform, this course is designed for mid-level to senior officials (civilian and military) dealing with cybersecurity issues, and is open to individuals from EU Member States, EU institutions, EU bodies and agencies, candidate countries, third countries, and international and regional organisations.

The ESDC is committed to an inclusive, gender-sensitive and discrimination-free environment. Only in an inclusive environment can all people, and therefore the ESDC and its partners, realise their true potential. We therefore particularly encourage applicants from under-represented groups to apply.



**Maximum number of participants:** 25.

**Nominations deadline:** 30 January 2025.

**Language:** English (without translation or interpretation).

**Target audience:** The course is open to mid-ranking to senior officials (civilian and military) dealing with cyber security issues and who are from EU Member States/EU institutions bodies and agencies, candidate countries, third countries and international and regional organisations.

**How to apply and deadline:**

- Applications from the **EU Member States and institutions** are to be filled in by the **national ENLIST nominators** via the ESDC secure registration system via the following link <https://esdc.europa.eu/enlist/login>, **no later than 30 January 2025**. **Registration:** registration will not be final until confirmed by the ESDC Secretariat. When the participants’ list is finalised, the course administrators will contact the selected participants and provide detailed information about the course.

**Please do not book flights and accommodation before receiving the confirmation message.**

**The selection of participants** will be based on applicant backgrounds, experience, suitability, gender balance and country of origin. The decision on which applications are accepted remains solely with the Training Institutions and the ESDC Secretariat. When the participants’ list is finalised, the course administration will contact the selected participants and provide more detailed information about the course and logistics.

**Liabilities, medical and life insurance:** In the event of medical emergencies or accidents, the costs will be covered directly by the health, life and accident insurance provided by the participants' sending countries, national authorities or organisations. The organiser does not provide health, life or accident insurance for participants at the event or during their stay in Belgium.

**Dress code:** business attire for all participants, both civilians and military personnel.

**Course (tuition) fees:** the course is free of charge. The sending authorities will cover all costs for travelling, accommodation and catering (including breakfast) for participants.

**Travel Arrangements:** Participants are kindly requested to make their individual travel arrangements (including for accommodation), in line with their sending authorities' guidelines. It is recommended that participants arrive at Brussels International Airport by 15 February 2025 at the latest. Further information will be sent to participants following registration.

**Meals:** The ESDC will host a social lunch on 16 February 2025. Coffee breaks will be provided at the course venue. Participants are kindly requested to arrange for all other meals. There is a number of options in the vicinity of the course venue.

**E-learning:** the course begins with an online (asynchronous) e-learning part on the ESDC's e-learning platform (ILIAS LMS), which needs to have been completed before the residential part begins. Both parts are compulsory. Detailed information will be shared with the selected participants.

**Supporting services:** all administrative information, programmes and material will be made available to the selected participants through the ESDC's e-learning platform (ILIAS LMS).

**Attendance:** is mandatory for all course days. A certificate will be awarded to those course participants who have completed the full course, including the mandatory e-learning modules.
